OPERATIONS

Open cut operations to finish in 2018

Open cut mining at Tomingley Gold Operations is scheduled to be completed in the July – September quarter of 2018. This is in line with the original project schedule, which saw all four open cut pits mined.

TGO continues to investigate the mineral resource under the Wyoming One pit via a drilling program, to determine the most profitable approach to underground mining. We'll have this done around the end of October, and then we'll look to make a decision at the end of the year. In addition, regional exploration continues for longer term development opportunities around Tomingley and down to Peak Hill.

ENVIRONMENT

Biodiversity management and feral cat control

As part of our commitment to improving biodiversity in the Tomingley area, certain areas onsite at Tomingley Gold Operations are designated as biodiversity offset areas. This means ongoing efforts are made to revitalise vegetation and grow or introduce populations of native wildlife.

An important part of this process is controlling the presence of noxious weeds and feral animals in these biodiversity offset areas. Feral cats are a particular problem, being the number one predator of many native birds and mammals. Some of these local species – such as the Superb Parrot (*Polytelis swainsonii*), Grey-crowned Babbler (*Pomatostomus temporalis*), and the Fat-tailed Dunnart (*Sminthopsis crassicaudata*) – are listed as threatened or venerable in NSW.

TGO's trapping program includes the placement of baited traps in various locations. While in place, these traps are checked daily by the environmental team. When a cat is trapped, it is checked initially for a collar and returned to the owner if identified, or else transported to a vet in Dubbo for microchip identification. Where it is clear that the cat is not domesticated, the cats are then humanely euthanised.
